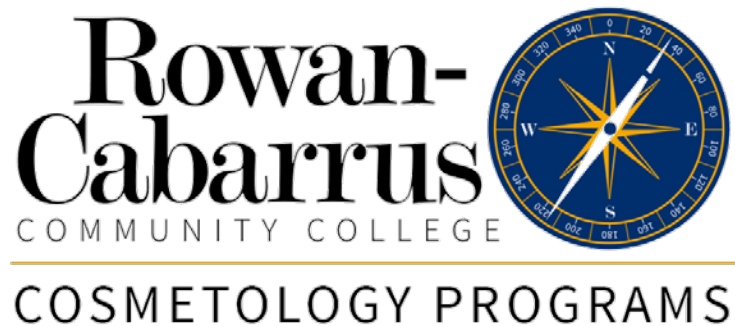

Licensing Options

Cosmetology License

Full-License: Accrue a minimum of 1500 hours with successful program completion to qualify for the NC State Board of Cosmetic Arts Examination.

Apprenticeship License: Accrue a minimum of 1200 hours with successful program completion to qualify for the NC State Board of Cosmetic Arts Examination. After state testing and receipt of the apprenticeship license the candidate must work an additional 6 months (full-time) in a salon with a licensed cosmetologist to qualify for full-licensure.

Esthetics License

Accrue a minimum of 600 with successful program completion to qualify for the NC State Board of Cosmetic Arts Examination.

Manicurist License

Accrue a minimum of 300 hours with successful program completion to qualify for the NC State Board of Cosmetic Arts Examination.

Cosmetology Instructor License

Students will prepare for North Carolina State Board of Cosmetic Arts Instructor Licensing exams. Students will receive basic instructor knowledge with hands on clinical experience.

Attendance Requirements

Attendance is **critical** to earn the required hours each semester to progress to the next semester.

Grade Requirements

All programs require successful completion of

- academic credit hours,
- clinical requirements,
- passing class grades of C or better
- mock exam grades of 85 or better in the graduating semester.

Registration Information

Applicants will be notified of program acceptance and registration.

Keep your contact information current (telephone number, email and address).

A Social Security card for any individual who has a social security number or tax ID card or student visa information and a Government issued photo ID must be received by the program administration.

You are not officially registered and cannot attend class until you have made payment arrangements through your student WebAdvisor account.
